Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal vatika shall be restricted to 3. The total number of sections from classes 1 to 12 shall be restricted to 13. Out of the total 16 sections (including Bal vatika), not more than 1/3rd may be used for senior secondary classes. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Byelaws and availability of rooms of >500 ft dimensions.
2	The school is required to develop the playground and improve outdoor sports facilities. Desks are seen instead of tables and chairs in the indoor sports room The school shall level the outdoor sports ground and upgrade the indoor and outdoor sports facilities as per SoP issued by the board within 3months and submit compliance on SARAS with videography.
3	Library is understocked. The school is required to increase the number of books in the Library i.e. 5 books per child and 10 magazines, 6 newspapers should be subscribed as per CBSE guidelines, create reading corner for staff and upgrade the library as per SoP issued by the Board and submit the compliance on the SARAS portal within 3 months.
4	The Physics and Biology labs are understocked. Chemistry lab is not seen.None of the labs have any seating arrangement. The school shall upgrade all science labs and submit the compliance through videography within 3 months on SARAS portal.

5	One common CWSN toilet on every floor is available with temporary signage, The school shall construct CWSN toilets, separately for boys and girls on every floor with proper permanent signage as per RPwD Act 2016 and Circular no. 5 dated 06.03.2023 and submit the compliance through videography within 3 months on SARAS portal.
6	The school has submitted the purchase order for lift in the reupload section. The school is required to upload the videography after the installation of the Lift within 3 months on the SARAS portal.
7	The composite lab is under stocked and not well laid out.there are only 2 work stations, ostensibly for bio(should be without shelves) and chemistry.No physics equipment is seen, for which there should be standard lab tables.The school shall upgrade the composite lab as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
8	A class room has been converted into math lab, with few equipment placed on a table and desks arranged class room style in place of proper work spaces for students.The school shall upgrade the math lab as per Sop issued by the board within 3months and submit compliance on SARAS with videography.
9	There are no partitions between urinals in the boys washrooms.the school shall partition the urinals within 3months and submit compliance on SARAs with videography.
10	The school shall ensure the training of its teachers with CoE Ajmer within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
